Tender will be opened in the office of Head Physics Department.
- Tender Processing fee should be paid through e- payment (Direct Debit or Internet Banking)
- The Tender documents shall be uploaded in 2 folders.
- Folder-A: Shall contain pre-qualification documents such as Registration, PAN No., GST, Income Tax Return and Non Black list Self certificate etc uploaded on website.
- Folder-B: shall contain financial bid on the prescribed form.
- In case earnest money is not deposited for not having the required value, the bids will not be considered and rejected straightaway.
- The folder-B: shall be opened only of those contractors who will be found technically qualified for the supply.

#### PRE-QUALIFICATION REQUIREMENTS: -

- The material is to be made available/ installed within four weeks from date of placing confirmed Purchase Order along with all the bills.
- If there is holiday on the receipt/opening day of the tender, the tender may be received/opened on the next working day at the same time and at the same place.
- The Purchase Committee reserves the right to reject the tender without assigning any
  reason before/after opening of the tenders and the tenderers shall have no right or any
  claim whatsoever for the same on this account.
- 7. University reserves the right to increase/ decrease the quantity of items. The order for quantity of different items can be increased or decreased. The supply order will be placed to the firm/Supplier which would submit quotation strictly as per the given detailed technical specifications. The Suppliers/ Tenderers shall have no right or any claim whatsoever for the same on this account.
- 8. The rate quoted by the Supplier/Tenderer shall be inclusive of all the taxes i.e. GST or any other taxes levied by Central Govt. or State Government Authority or Local Bodies including their variations as notified by the Concerned Authority from time to time and of all the new taxes and levies that may be imposed. For all Items, firm will supply the material on quoted Rates which include F.O.R., Loading, Unloading, stacking and inclusive of all taxes. Nothing Extra shall be paid.

The Supplier/ Tenderer/Manufacturer shall comply with the proper by- Laws and legal order of the local body or authority under the jurisdiction of which the supply is executed and pay all fees and charges for which he may be liable. Nothing extra shall be payable by the University on this account.
